	<u>Jennifer McKee – 453 Thorn Run Road Driveway</u> Jennifer McKee was present to ask the Board for their assistance with their driveway on Thorn Run Road. The paving company contracted by XTO Energy did not provide a wide enough apron for the ingress and egress of their property.
	Harry Mottern - Road Inspection Harry Mottern expressed his opinion on how road inspection was conducted. He further stated that the culvert pipes on Thorn Run Road in front of the stone house have sunk.
	Dan Genoway –St. Joe Road Stormwater Dan Genoway asked the Board to direct the road crew to install a culvert pipe that he is willing to purchase to help with some of the issues of storm water on St. Joe Road. The Board agreed that the road crew would install the pipe, as this is a serious issue. Supervisor Paul McEachin stated that the offer should be made to everyone on the road and Nadine Neff was directed to prepare letters and send them to residents the entire length of St. Joe Road.

	Lonny Jewart – Lonny Jewart met with Suit Kote and they still say that their oil was good and that the stone provided by M&M Lime was bad. They did admit that there were some problems and their solution if that they will put down E3 primer and sand to make it aesthetically pleasing. Lonny asked their representatives to come to the Board meeting or put their offer in writing and they have done neither. The Board agreed that we should continue to seek relief through their bonding company.
	Lonny gave to the Board a copy of the dates that the road crew will be shooting oil. The dates are the end of July and the middle of August. Lonny is to give Shaun Krill a list of the assignments for the road crew to complete while he is away on guard duty.
	Sean Gramz - Sean reported that he is still making his recommendation on our current driveway ordinance and recommends that e update the ordinance to reflect the correct publications 403 and 72. He stated that a copy of the fee resolution should be make part of our application.
